Synopsis: To open investigation on captioned matter.

Details: On 01/30/2008, at least nineteen envelopes containing an unknown white powder and a one page statement were received via the U.S. Postal Service at numerous Church of Scientology locations in Southern California. The envelopes were processed at the Santa Clarita California Processing Center with a date stamp of 01/29/2008. Each envelope had an attached typed/printed label which was addressed to "Scientology" with the corresponding address. There was no return address on the envelopes. The primary Church of Scientology location in Los Angeles, CA (1308 L. Ron Hubbard Way) received multiple white powder envelopes.

The FBI, U.S. Postal Inspection Service, and Los Angeles Police Department (LAPD) responded to initial locations reported by the Church of Scientology. On-scene field screening was conducted, and all materials in the envelope tested benign. There was evidence of some biological material (possibly starch). The powder was screened according to standard protocol, to include flammability, corrosiveness, radiological, volatility, and oxidizers. Samples are being transported to the public health laboratory (LRN) in Los Angeles, CA for definitive testing.

Each standard size business envelope contained a small but noticeable amount of white powder with a one page typed/printed statement on standard white paper containing the following information:

"Hello Scientology,

We are Anonymous. Over the years, we have been watching you. Your campaign of misinformation, suppression of dissent; your litigious nature, all of these things have caught our eye. With the leakage of your latest propaganda video into mainstream circulation, the extent of your maligned influence over those who trust you, who call you leader, has been made clear to us. Anonymous has therefore decided that your organization should be destroyed. For the good of your followers, for the good of mankind -- for the laughs we shall expel you from the Internet and systematically dismantle the Church of Scientology in its present form. We acknowledge you as a serious opponent, and we are prepared for a long, long, campaign. You will not prevail forever against the angry masses of the body politic. Your methods, hypocrisy, and the artlessness of the organization have sounded its death knell.

You cannot hide; We are everywhere.

We cannot die; we are forever. We are getting bigger everyday -- and solely by the force of our ideas, malicious and hostile as they often are. If you want another name for your opponent, then call us Legion, for we are many.

Los Angeles Assistant United States Attorney [redacted] was made aware of the investigation and advised that federal law was violated and is willing to prosecute those responsible.

Mailings to Scientology sites probed

Mailings of a suspicious white powder to 10 Church of Scientology addresses prompted the evacuation of dozens of people and the closure of a major thoroughfare Wednesday as hazmat teams were called to examine the packages.

The letters were sent via the Postal Service to Scientology properties in Hollywood, the San Fernando Valley, Santa Monica, Glendale and Tustin. Police shut part of Glendale's busy Brand Boulevard for two hours before sounding the all-clear, while 60 people were cleared from buildings in Tustin, authorities said.

The incidents appeared to be part of a malicious hoax. Preliminary tests showed the powder to be cornstarch and wheat germ. More tests are pending, authorities say.

"Initial field testing by LAPD indicates the powder is harmless," said FBI spokeswoman Laura Eimiller. "However, further testing will be conducted. We will also work to assess what threat, if any, was associated with the mailings and determine whether any federal statutes were violated."

The Church of Scientology had no comment about the incidents Wednesday. The mailings come after a cyber attack last week on the Church of Scientology's website, which caused it to shut down for a day. Authorities said there was no evidence that Wednesday's mailings were connected to the hacking.

Scientology feud with critics takes to Internet

Cyber attacks and threats against the church erupt after it asks YouTube to pull Tom Cruise clips.

A long-simmering dispute over digital copyrights between the Church of Scientology and its critics has boiled over in recent weeks after video clips turned up on the Internet from a 2004 interview by the church's most famous member, actor Tom Cruise.

When Scientology officials complained the clips were copyrighted and requested their removal from YouTube and other websites, a shadowy organization of online trouble-makers sprang into action.

The group known as "Anonymous" posted an eerie video on the Internet featuring a computer-generated voice announcing a campaign to destroy the church and calling for worldwide protests Feb. 10.

"It was all for laughs," said a member who spoke on the con-

dition of anonymity. But things are now getting serious. A series of cyber attacks the group claimed responsibility for slowed access to church websites and apparently shut down the main one, www.scientology.org, one day last month.

As of Friday, suspicious white powder was mailed to 23 church locations in Southern California, forcing 60 people to be cleared from buildings in Tustin and causing police to close part of busy Brand Boulevard in Glendale for two hours. Preliminary tests by the LAPD determined the powder was cornstarch and wheat germ.

The FBI is investigating whether the mailings were connected to the hacking. Shortly after the mailings were disclosed by authorities, a caller who identified himself as a spokesman for the group Anonymous told a Times reporter that the group was not to blame.

The incidents have drawn new attention to Scientology.

Critics of the religion are flocking to Anonymous postings on YouTube, the popular video-sharing site. Their campaign has sparked a debate among long-time Scientology's opponents, who wonder

whether the aggressive rhetoric and tactics, including illegal denial-of-service attacks on the church's websites, help the cause by raising awareness of the religion's controversial beliefs, or hurt it by using the same type of heavy-handed methods they accuse Scientology officials of employing against critics.

"I don't know if anybody in Anonymous did this but Anonymous set themselves up to be targeted in this way..." said Mark Bunker, who runs one of the leading websites criticizing the church, www.xenu.tv, and posted a video last week warning Anonymous to tone down its campaign.

"I hope it doesn't hurt the larger critic community who have been speaking out for years about Scientology's abuse."

Scientology was founded in 1954 by science fiction author L. Ron Hubbard. It teaches that "spiritual release and freedom" from life's problems can be achieved through one-on-one counseling called auditing, during which members' responses are monitored on an e-meter, similar to a polygraph. The process, along with a series of training courses, can cost

Scientologists tens of thousands of dollars.

Cruise has become an outspoken proponent of the religion. In 2004, he won the International Assn. of Scientologists Freedom Medal of Valor award and part of the ceremony included a taped interview with him talking about why the religion is important to him.

The video was posted on YouTube and other sites this month, leading the Church of Scientology to request its removal for copyright violation.

A Scientology spokeswoman said the church wasn't trying to suppress the video, which it says can be watched at any of its facilities around the world. But it was made for "the Scientology congregation" and "never intended for replay on television or the Internet," spokeswoman Karin Pouw said in a written response to questions.

The requests to have it removed are similar to take-down requests by movie studios and TV networks, she said. But members of Anonymous were angered by the requests and decided to take on the church, said the group's representative.

The group is a loose confederation of about 9,000 people who post anonymous messages in chat rooms on websites he would not identify. While they are experienced Internet users, few are computer hackers, he said. But there are enough people with knowledge of how to attack websites that they were able to launch the attacks, the spokesman said. One of the attacks, known as distributed denial of service, involves flooding a website with requests, overloading its capacity.

Pouw said Scientology's websites "have been and are online." But Danny McPherson, chief research officer at Arbor Networks, which works with Internet service providers to detect and prevent cyber attacks, said they observed about 500 denial-of-service attacks on the Scientology site in the past week.

The Church of Scientology also shifted the company that hosts its site last week to Prolexic Technologies Inc., which specializes in stopping denial-of-service attacks.

An online onslaught against Scientology

A VICIOUS cult run by cynical fraudsters, or a sincerely held religious belief persecuted by zealots? That is the long-standing row about Scientology founded by the late science-fiction writer, L. Ron Hubbard. In some countries, such as Germany, the group is watched by the security services. In others, such as America and Australia, it has won charitable status as a religion.

Until now the fight could mostly be seen as one-sided. Scientology's lawyers are vigorous litigants. The group argues that its internal materials (which claim, among other things, that expensive courses of treatment can help rid people of infestation by alien souls from an extinct civilisation) are commercially confidential and protected by copyright. They react sharply to any perceived libel.

As a result, public critics of what they denisively term "Scientology" risk expensive legal battles. For example, a new unauthorised biography of Tom Cruise by a British author, Andrew Morton, contains detailed and highly critical material about the film star's involvement in Scientology. It is a bestseller in America but has not been published in Britain. The publisher, St Martin's Press, has even asked internet booksellers not to ship it to foreign customers. Though Scientology representatives vehemently deny breaking any laws, critics have claimed that they experience intensive harassment and intimidation.

Now Scientology is under attack from a group of internet activists known only as Anonymous. Organised from a Wikipedia-style website (editable by anyone) and through anonymous internet chat rooms, "Project Chanology", as the initiative is known, presents no easy target for Scientology's lawyers. It is promoting cyberwarfare techniques normally associated with extortionists.



Watch out, there's an alien about

spies and terrorists. Called "distributed denial of service attacks", these typically involve using networks of infected computers to bombard the target's websites and servers with bogus requests for data, causing them to crash. Even governments find this troublesome.

Anonymous is also hoping to galvanise public opinion with a mass "real-world" protest outside every Scientology office worldwide on February 10th. But its best weapon may be ridicule. The group got going in reaction to efforts to ban an internal Scientology video of Mr Cruise that leaked onto the internet. The star appears to discuss his beliefs with a degree of incoherence and exaggeration that might lead some to question Scientology's effects on its adherents' sanity. A Scientology spokesman says it has been selectively edited. Several internet sites have taken it down after threats of lawsuits. But it keeps popping up.

Global Scientology protests include L.A.

Anonymous, the loosely bound group of Internet activists who have targeted the Church of Scientology in recent weeks, showed up Sunday morning to protest at the church's largest Los Angeles locations.

The rallies were part of a global day of demonstrations against Scientology organized by the group, with picketers in New York, Toronto, Britain, Australia and other locations.

The protests were peaceful, with music and chanting. Many of the Los Angeles picketers wore the Guy Fawkes masks made popular in the movie "V for Vendetta."

A near-constant stream of horn honks provided background noise for protesters at the Scientology center on Sunset Boulevard. After about two hours, the group headed to a Scientology church on Hollywood Boulevard.

Security personnel, some with video cameras, were stationed at entrances to both locations. A Fawkes-masked spokesman for Anonymous,

who wouldn't give his name but whom several protesters identified as the organizer of the L.A. event, said, "We want to set off a government investigation into how [Scientology] got tax-exempt status."

The church was granted tax-exempt status in 1993 after a protracted battle with the IRS, which for 25 years had maintained that Scientology was a business, not a religion.

Contacted for comment on the protests, a Scientology representative issued a statement that called Anonymous "a group of cyber-terrorists" that is "perpetrating religious hate crimes against Churches of Scientology and individual Scientologists for no reason other than religious bigotry."

Asked to explain the groundswell of opposition, protester and former Scientology member Lynn Fountain Campbell, who said she had been part of the church for 40 years, said, "It's just reached a critical mass. People just aren't scared anymore."

"They try to make people shut up," she said, "and I'm not the shutting up type."

The author spoke to him several times over two different days. His interviews identified intelligence regarding the harassment campaign against the church and highlighted several areas of potential follow-up for the case agents.

First, the San Diego church is in the process of having its telecommunications service provider, Telepacific, identify the telephone numbers of harassing calls to its offices (several harassing calls specifically mentioned ANONYMOUS). [redacted] of Telepacific's Fraud and Loss Division, (866) 839-8545, is responsible for accomplishing this. Once the numbers have been identified, Telepacific will provide the numbers to the San Diego Police Department (Detective [redacted]), based upon that agency's ongoing investigation into the harassing telephone calls. The results of Telepacific's work may also be useful in further identifying the subjects in Los Angeles' case.

The emails contained header information that may identify the sender(s) of the emails, although it is likely that the true source of the emails is hidden behind email servers and personal computers that have been compromised by ANONYMOUS. The emails were saved in their original Microsoft Outlook format. The attachments were saved on the disk as separate files. They are being forwarded to Los Angeles for further analysis.

Third, [redacted] provided details of various harassment techniques being used against the San Diego branch of the church. These details may be useful in identify patterns which assist further in the task of identifying the individuals responsible for the threats.

Finally, on 2/27/08, the San Diego church experienced a suspicious event. At approximately 6:30 p.m. a female, described as white, in her 30s or 40s (further descriptions vary), entered the church reception area and indicated that there was a suspicious backpack by a church dumpster. She indicated several times that the church ought to call the police. The female provided the information in a manner that seemed suspicious. [redacted] felt that the female was trying to prompt the church into treating the backpack as a threat, because up until that point,

the church had ignored it. The female did not identify herself. Later, around 6:50 p.m., the church received its first and only harassing call of the day.

[redacted] the backpack from another church member and secured it in a church utility closet. [redacted] subsequently took the backpack and placed it into evidence in case it is found to be related to the recent threats against the church.

She has also traveled to Los Angeles to participate in picketing activity against the church located there. Web awash in critics of Scientology

The church's tightly controlled image is taking hits as soured ex-members go online.

"We were born. We grew up. We escaped."

So reads the motto of ExScientologyKids.com, a website launched Thursday by three young women raised in the Church of Scientology who are speaking out against the religion. Their website accuses the church of physical abuse, denying some children a proper education and alienating members from family.

One of the women behind the site, Jenna Miscavige Hill, is the niece of David Miscavige, the head of the church, and Kendra Wiseman is the daughter of Bruce Wiseman, president of the Citizens Commission on Human Rights, a Scientology-sponsored organization opposed to the practice of psychiatry.

The day before ExScientologyKids.com launched, another inflammatory allegation about the church began to circulate virulently online. "L. Ron Hubbard Plagiarized Sci-

entology," read a headline at the popular Internet culture blog BoingBoing. The post linked to images of a translated 1934 German book called "Scientologie," which critics say contains similar themes to Hubbard's Scientology, which he codified in 1952, according to a church website.

These were just the latest in a series of Scientology-related stories to burn across the Internet like grass fires in recent weeks, testing the church's well-established ability to tightly control its public image. The largest thorn in the church's side has been a group called Anonymous, a diffuse online coalition of skeptics, hackers and activists, many of them young and Web-savvy. The high-wattage movement has inspired former Scientologists to come forward and has repeatedly trained an Internet spotlight on any story or rumor that portrays Scientology in

unflattering terms.

No corner of the Web, it appears, is safe for Scientology. Blogger and lawyer Scott Pilutik recently posted a story noting that Scientology was yanking down eBay auctions for used e-meters, the device the church uses for spiritual counseling. eBay allows brand owners — Louis Vuitton or Rolex, say — to remove items they believe infringe on their trademark or patent rights. Basically, fakes. But, Pilutik said, the used e-meters being taken down were genuine. Reselling them was no different than putting a for-sale sign on your old Chevy.

"What's actually going on here," he wrote, is that the church is "knowingly alleging intellectual property violations that clearly don't exist." Within a day Pilutik's blog had gotten over 45,000 visitors — so much traffic that his site crashed completely.

Facing a steady stream of

negative publicity and a growing number of critical voices, Scientology has found itself on the defensive.

The church has referred to Anonymous as a group of "cyber-terrorists" and, in a statement, said the group's aims were "reminiscent of Al Qaeda spreading anti-American hatred and calling for U.S. destruction."

"These people are posing extremely serious death threats to our people," said church spokeswoman Karin Pouw in a phone interview. "We are talking about religious hatred and bigotry."

A recent video posted to YouTube contained a threat to bomb a Southern California Scientology building. An FBI spokeswoman said an investigation was in progress but that no suspects had been identified.

Reporters have long had to tread carefully when writing about Scientology, fearful that

lawsuits and other kinds of retaliation would follow any story that Scientology did not like. But that may be changing.

"Before this Internet onslaught," said Douglas Frantz, a contributing editor at Portfolio magazine who covered Scientology for the New York Times in the 1990s (and is a former editor at the L.A. Times), "they were always able to go after their critics and do a good job of being able to discredit or intimidate them."

Angry former church members also perceive a kind of safety in numbers afforded by the Internet, and more are coming forward to share their stories.

"People have been scared out of their minds to speak out about Scientology," said Hill, Miscavige's niece, in an interview. "Nobody should have to be that scared to speak out about a church."

Wiseman echoed the sentiment, adding that the Anonymous campaign had influenced her decision to reveal her identity last week. "The Internet is listening. If something happens to me, all of these people will know."

The current wave of anti-Scientology activity began in January, when a video of Tom Cruise extolling the religion's tech-based approach to enlightenment was leaked onto YouTube, where users holding it up to ridicule copied and re-copied it; several sites posted it without hesitation.

It wasn't long before Nick Denton, who as publisher of the blog syndicate Gawker Media had put the video online first, received a legal threat from a law firm representing Scientology, alleging copyright infringement. But Denton refused to take the video down.

"It was an awesome news story," Denton wrote in an e-mail. "If we didn't race to post it up, some other site would have. That, rather than litigation by Scientology, was the fear going through my mind."

The church's whack-a-mole campaign with the Cruise video became a rallying cry for Anonymous, which saw efforts to remove the videos from YouTube as an unwanted incursion into the domain of digital culture, where information and media, copyrighted or no, are

often exchanged freely.

In a YouTube video of its own, Anonymous declared open war on the church. Early on, the group also staged cyber-attacks on Scientology websites.

But on Feb. 10, thousands of masked Anonymous members picketed at Scientology locations around the globe, chanting slogans and handing out fliers. No violent incidents were reported. The protests generated yet another wave of online media — videos, photos, news stories, blog posts — little of it in praise of Scientology.

The result of all this attention has been that just about any story critical of Scientology — even those that have been publicly accessible for years — can gain immediate Web currency. On Digg.com, a popular "social news" aggregator that features popular stories from around the Web, dozens of Scientology stories have ascended to the site's most-viewed list in the last several weeks. A successful Digg story can drive tens of thousands of views to the originating site, as was the case with Pilutik's post about e-meters.

In addition, the clamor generated by Anonymous has raised the profile of the small but vehement anti-Scientology community that existed before Anonymous, and even made for some cross-pollination between the two camps.

Scientology's longtime detractors, such as those at Operation Clambake (xenu.net) and Scientology Lies, claim it is not a religion at all but a business that charges its parishioners ever more onerous fees for access to revealed truths. Other online forums, such as the Ex-Scientologist Message Board and ExScientologyKids, have become places for former members to congregate, share stories and offer support.

Ironically, it is the church's aversion to negative publicity — and the legal strategy it has long used to prevent it, that has aroused more online ire than any other issue.

The website ChillingEffects.com has posted dozens of cease-and-desist letters sent by Scientology's lawyers to various website and Internet service providers requesting that copyrighted material be re-

moved.

But in the diffuse and often Byzantine world of the Web, some precision legal strikes are more likely to backfire than hit their target. Scientology's use of copyright law appears to be an increasingly losing battle on the Web, said Andrew Bridges, a San Francisco-based intellectual property attorney. "The big question is: Is the copyright, serving the purpose of promoting science and the useful arts, or is the purpose essentially the stifling of criticism?"

Still, according to Scientology spokeswoman Pouw, the church views the Internet as a positive tool. It is, Pouw said, "concentrating on using the Internet as a resource for promoting its message and mission in this world, not as a ground for litigation."

But now that goal will have to exist alongside a seemingly steady stream of online attacks. And while anonymous political activity, such as posting around a town, is nothing new, Bridges noted, the speed of the Web is what is giving Scientology trouble.

"What's different is that more people can see the stuff faster than Scientology can go around and get it taken down."

From January 30, 2008, through March 07, 2008, members of the Los Angeles Division Hazardous Materials Response Team (HMRT-LA) assisted in the collection of evidence related to the captioned investigation.

On January 30, 2008, about numerous churches of Scientology in Los Angeles, Orange and San Bernardino counties received letters containing threatening language and an unidentified white powder. Hazardous materials units from local law enforcement, health and fire agencies responded and collected the letters. FBI personnel, including SA [redacted] HMRT-LA coordinator, SA [redacted] WMD coordinator, and SA [redacted] assistant WMD coordinator, went to some of the incidents in Los Angeles and Orange counties to help assess the situation and liaison with local responders.

In Orange County, SA [redacted] an HMRT-LA member, supervised the collection of three letters and their transport to the Orange County Public Health laboratory, a member of the Laboratory Response Network (LRN). At the laboratory, the letters were tested for contamination with bioterror agents.

HMRT-LA did not collect any letters the evening of the incident. The letters were collected by the police departments in the affected jurisdictions or the Los Angeles County Sheriff's Department.

From February 7, 2008, through March 25, 2008, HMRT-LA members took custody of letters that had been collected by local police departments at the churches of Scientology. SA [redacted] subsequently screened all items for radiological and chemical hazards, per Hazardous Materials Response Unit (HMRU) protocols. On February 14 and February 27, HMRT-LA members delivered the letters to the Los Angeles County Public Health (LACPH) laboratory, a member of the LRN, for testing.

The attached spreadsheet documents HMRT-LA's collection and handling of the letters. Enclosed in a 1A envelope are supporting documents, including HMRU Field Screening Matrices, FBI chains of custody, LACPH laboratory chains of custody and associated FD-597s.

SUMMARY

On February 8, 2008, at 2145 hours, Suspects #1 and #2, later identified respectively as [] a male Caucasian [] years of age, with an [] and [] colored hair, and [] a male Caucasian [] years of age, with an [] and [] were observed by Church of Scientology (COS) security officers walking around the Church of Scientology building located at 1404 North Catalina Street. The suspects were approached by security officer [] a male Caucasian, [] years of age, on the street near the north perimeter of the COS. Security Officer [] had a brief discussion with [] and [] at which point [] stated, [] walked away from [], got into a [] compact vehicle and drove away

from the location without further incident. [redacted] was the driver.

[redacted] reported this contact with COS Security manager [redacted] who obtained digital surveillance images of [redacted] and the [redacted] compact vehicle. The surveillance footage captured clear images of both [redacted] looking into one of the doors to the church as well as the [redacted] they drove leaving the location. The footage of the [redacted] included the license plate number of the vehicle as [redacted]

I, Detective [redacted] and I, Detective [redacted] Major Crimes Division, Criminal Conspiracy Section (MCD/CCS) assumed the investigative responsibility for this incident .

Note: On January 30, 2008, several offices and churches of the Church of Scientology in the City of Los Angeles received typewritten letters from an anonymous suspect/s containing anti Church of Scientology rhetoric and an unknown powder. The sender only identified themselves as "Anonymous." Detectives determined that "Anonymous" is an Internet based group that overtly opposes the Church of Scientology and has targeted the church with a campaign of telephonic threats, computer based denial of service attacks, protest marches, and white powder sent inside envelopes addressed to several offices of the Church of Scientology. Detectives also determined that the members of "Anonymous" are located throughout the United States and frequently use the Internet to communicate, and target the church with various types of threats.

CCS detectives were assigned the investigative responsibility of the numerous cases targeting the church and have received a great deal of investigative cooperation from officials at the church concerning the Denial of Service attacks, telephone threats and their associated records, as well as regular updates concerning the current attack campaign against the church by "Anonymous." This incident involving [redacted] was believed to be yet another intentional confrontation with the Church of Scientology on behalf of "Anonymous."

INVESTIGATION

On February 18, 20089, Detective [redacted] obtained the registered owner information of the gray Scion vehicle involved in this case via a check of Department resources. The registered owner was listed as [redacted] a male Caucasian with a date of birth date of [redacted] and a listed address of [redacted] in Hollywood. Detective [redacted] subsequently obtained [redacted] California Drivers License record information and photograph. [redacted] California Drivers License listed his residence as [redacted] in North Hollywood. Detective [redacted] showed me [redacted] Drivers License photograph and we formed the opinion that it was in fact [redacted] who was captured on the digital surveillance footage provided to us by the COS based on his physical facial characteristics, complexion and hair color [redacted] hair). On February 20, 2008, Detective [redacted] and I arranged to meet with COS Security Officer [redacted] at Northeast Station at 1800 hours. We met with [redacted] at Northeast station where we explained to him that we developed additional possible suspect information in this case and subsequently conducted a photo line up which included a photograph of [redacted] in position number 6. [redacted] identified [redacted] in position number 6 as the person who was the accomplice to the individual based on the physical appearance of his eyes, mouth and hair color. [redacted] added that [redacted] was not person who made the reported statement that the church was going to burn. He reiterated that it was the other individual whom he described as a male white with an extremely thin build, and long light colored hair that actually made the threat.

On August 13, 2008, at 1410 hours, Detective [redacted] MCD/CCS, and I, located and interviewed [redacted] at his residence located at 12204 Huston Street in North Hollywood this interview was surreptitiously digitally recorded by Detective [redacted] statement is summarized below as follows.

I explained to [redacted] that I was investigating a case concerning the church of Scientology from

earlier in the year where he and another individual went to one of the churches of Scientology. He remembered the day he and his friend that he named as [redacted] years old, went to two COS locations. He first told us that [redacted] was his best friend of the last two to three years who moved to Arizona and that they stopped talking to each other over the COS. [redacted] got involved with a girl who screwed him up. He knew the girl's name as [redacted] a fake name, and believed that she was involved with the COS. She was trying to take [redacted] to AA meetings and give him medication. She never talked about the COS, but he remembered that he met her outside the church at the bourgeois pig coffee shop about three to four years ago. He told [redacted] that the girl was trying to get him in the program. [redacted] moved in with her. He described her as a witch who read tarot cards. [redacted] complained to him that he felt suicidal at times, and thought that she was going to kill him at some point. He told [redacted] that they just have to leave the city because she would always find him. He told [redacted] that they should go to Arizona they did a few months ago and he felt that they were followed because they saw some cars that appeared to be following them. On one occasion they went to a Chili's restaurant in Alamos Colorado and he felt that he might have been poisoned. He suspected Scientology because [redacted] is a talented drummer and is someone they would try to recruit. He never saw [redacted] give [redacted] any medication but remembered that she had a lot of medication in her house. She lived somewhere near Lankershim and the Superior Warehouse market. He last spoke to [redacted] three months ago

He told me he sold his [redacted] to make the move with [redacted] to Sedona Arizona. He further described [redacted] as having blond hair blue eyes, 152 lbs, and skinny and that he was from Sweden. He speaks English with no accent and one a drumming championship. [redacted] wore tight jeans and wore hats and glasses and a hat like a crazy guy. . I showed [redacted] the surveillance photos depicting him and another individual he identified as his friend [redacted]. He remembered going to the COS office on Hollywood Boulevard first to ask about [redacted] and if she was in the COS data base. When they got there the security told them to leave. Then they went to the other COS building by the hospital and that's when they were stopped by a security guard. [redacted] went off on the security guard by saying [redacted]. [redacted] I told him that he didn't have to do that. He was threatening them at Sunset. He was just frustrated about what was going on. He didn't know what was going on with himself and he made the threats. The security guard told him that he wasn't causing him any problems. No one else was present on the street at this time. No one else was in his car. This happened on the sidewalk. The security guard came to them on his bike. They didn't approach anyone when they were there. After they moved to Arizona, [redacted] turned on [redacted] blaming him for the whole problem that he had with Scientology.

[redacted] lastly provided us with an email address for [redacted] and state that he would probably respond to any emails I might send him. [redacted] preferred not to be mentioned in any future conversations that I might have with [redacted] concerning this investigation because he's trying to move on with his life. I confronted [redacted] about any involvement he might have with an Internet group calling themselves. [redacted] did not recognize the name "Anonymous" and was not aware of any "Anonymous" related actions. I formed the opinion based on his candid response and cooperation and that fact that I did not observe any "Anonymous" related materials in his room that he did not in fact have any connection with "Anonymous."

On August 14, 2008, I conducted a search of Department resources and identified [redacted] through his California Drivers License record. I prepared a photo line display card containing [redacted] photograph in position number 3 for witness identification purposes and labeled the display card "B." Details: On 01/30/2008, several envelopes containing a white powder substance and a one page statement were received via the U.S. Postal Service at numerous Church of Scientology (COS) locations throughout Southern California. Each envelope was processed and post marked out of the U.S. Postal Service processing center in Santa Clarita, CA with a date of 01/29/2008. Each envelope had an attached typed/printed label which was addressed to "Scientology" with the corresponding address. No return address appeared on the envelopes. To date, a total of 30

such envelopes were received at COS locations in the Southern California Area.

Law enforcement response to this incident involved FBI, U.S. Postal Service, Los Angeles Police Department (LAPD) and numerous other local law enforcement agencies. On-scene field screening was conducted, and powder material in the envelope(s) tested benign. There was evidence of some biological material (possibly starch) in the white powder samples tested. The powder was screened according to standard protocol, to include flamability, corrosiveness, radiological, volatility, and oxidizers. Each of the envelopes recovered were submitted to the local public health laboratory (LRN) in Los Angeles for definitive testing.

Laboratory findings were negative for all Category A bacterial bio-threat agents, *Brucella* species, and *Burkholderia mallei*, *B. psuedomallei*, and *Coxiella burnetti*; testing for orthopox virus was also negative. Testing for Ricin and Staphyloccocal Enterotoxin B (SEB) by Time Resolved Fluorescence (TRF) was negative; testing for other chemical agents was not performed.

Of the envelopes received, approximately 1/3 of the white powder letters were received at locations within the city of Los Angeles City territory. LAPD requested that the letters received within their territory be tested by an LAPD laboratory for forensic evidence. Due to the Joint nature of the investigation in this matter, a decision was made to provide these items recovered within the city of Los Angeles to LAPD for testing by an LAPD laboratory. All tests conducted by LAPD's Laboratory were completed according to strict protocol using a process which renders the evidence unusable for further forensic examination following these tests. Results of the examinations performed on these items of evidence were negative for fingerprints or trace evidence.

The remaining items of evidence recovered from this incident (as listed above) are hereby submitted to the FBI Laboratory for forensic examination. The FBI Laboratory is requested to to conduct examinations on the submitted items for the presence of trace evidence, fingerprints, etc. If detected, conduct appropriate DNA analysis.

The paper fragments designated specimens Q1.11, Q3.6, Q5.7, Q8.8, Q11.6, Q13.6, Q16.6, Q19.6, Q22.6, Q26.6, Q30.5, Q37.6, Q39.6, Q42.6, and Q45.6 have cut edges that are suitable for comparison with other suspect paper fragments.

No watermarks were observed on any of the submitted specimens.

Synopsis: Documents placement of case in Pending Inactive status.

Details: On 01/30/2008 a total of 30 envelopes containing a white powder substance a one page statement were received via the U.S. Postal Service at numerous Church of Scientology (COS) locations throughout Southern California. Evidence suggests that each envelope was processed and post-marked via the U.S. Postal processing center in Santa Clarita, California on 01/29/2008. Each envelope was labeled with a printed label which was addressed to "Scientology" with a corresponding address. The one page statement in each envelope was signed "Anonymous", apparently referring to a group who was voicing protests against the policies and practices used by the Church of Scientology.

To date all investigative leads have been covered with negative results. Field tests and Laboratory tests for biological agents met with negative results for all Category A bacterial bio-threat agents, *Brucella* species, and *Burkholderia mallei*, *B. psuedomallei*, and *Coxiella burnetti*; testing for orthopox virus was also negative. Testing for Ricin and Staphylococcal Enterotoxin B (SEB) by Time Resolved Fluorescence (TRF) was also negative.

Tests conducted by the FBI Chemistry Unit revealed that the white powder specimens were consistent with starch. Results of the examination by the FBI Trace Evidence Unit (Hair and Fiber) found textile fibers of different types and colors were found on some specimens and have been preserved for possible future comparisons. The specimens were examined visually using stereomicroscopy and comparison microscopy. As of instant date, examinations remain to be completed by DNA Analysis Unit I (Nuclear), Latent Print Operations Unit and the Questioned Documents Unit at the FBI Laboratory. In addition, some items of evidence (received within LAPD territory) have been submitted by LAPD Criminal Conspiracy Unit to the LAPD Laboratory for forensic examination. To date, results from the LAPD Lab have been negative for evidentiary leads.

No other incidents of a similar nature to this matter have occurred since the white powder mailings were originally received in late January, 2008. This case has been run as a cooperative effort with LAPD, Major Crimes Division, Criminal Conspiracy Section, Detective III [REDACTED]

This report contains the results of the nuclear DNA analyses.

Results of Nuclear DNA Examinations:

Specimens Q1, Q3, Q5, Q8, Q11, Q13, Q16, Q19, Q22, Q26, Q28, Q30, Q37, Q39, Q42, and Q45 were subjected to deoxyribonucleic acid (DNA) typing by the polymerase chain reaction (PCR) at the amelogenin sex typing locus, and where appropriate, the nine short tandem repeat (STR) loci of the AmpF Φ STR \circledR Profiler PlusTM ID PCR Amplification Kit and/or the six STR loci of the AmpF Φ STR \circledR COfilerTM PCR Amplification Kit.¹

Based on the typing results from the amelogenin locus (for sex determination), female DNA is present in the DNA obtained from specimen Q8. Male DNA is present in the DNA obtained from specimen Q28. The amelogenin typing result obtained from specimens Q30 and Q45 does not satisfy the Nuclear DNA Unit reporting criteria; therefore, no conclusion can be offered. No amelogenin typing results were obtained from specimens Q1, Q3, Q5, Q11, Q13, Q16, Q19, Q22, Q26, Q37, Q39, and Q42.

No STR typing results were obtained from specimens Q1, Q3, Q5, Q11, Q13, Q16, Q19, Q22, Q26, Q39, and Q42.

The DNA typing results obtained from specimen Q8 are consistent with having arisen from a single individual. With the exception of STR location D8S1179, these results are not suitable for matching purposes.

The DNA profile obtained from specimen Q28 is consistent with having arisen from a single individual and is suitable for comparison purposes.

The DNA typing results obtained from specimens Q30, Q37, and Q45 are not suitable for matching purposes; however, they may be utilized for exclusionary purposes.²

The DNA profile for specimen Q28 will be entered into the Combined DNA Index System (CODIS) and maintained by the FBI Laboratory for future comparisons. If future comparisons are requested, a known blood or buccal (saliva) sample from the suspect should be submitted.

No other nuclear DNA examinations were conducted.

Methods/Limitations:

The following methods and limitations apply to the results/conclusions provided in the results section(s) of this report and are referenced by number in the body of the text for clarity.

1: The AmpF λ STR \circledR Profiler PlusTM ID PCR Amplification Kit includes the STR loci D3S1358, vWA, FGA, D8S1179, D21S11, D18S51, D5S818, D13S317, and D7S820. The AmpF λ STR \circledR COfilerTM PCR Amplification Kit includes the STR loci D3S1358, D16S539, TH01, TPOX, CSF1PO, and D7S820. The AmpF λ STR \circledR Identifiler \circledR Plus PCR Amplification Kit includes the STR loci D8S1179, D21S11, D7S820, CSF1PO, D3S1358, TH01, D13S317, D16S539, D2S1338, D19S433, vWA, TPOX, D18S51, D5S818, and FGA. The AmpF λ STR \circledR MiniFilerTM PCR Amplification Kit includes the STR loci D13S317, D7S820, D2S1338, D21S11, D16S539, D18S51, CSF1PO, and FGA. Due to the differences in sample quality and/or quantity, amplification may not be attempted using each kit. Insufficient DNA quality and/or quantity can affect the ability to generate a DNA typing result and is not an absolute determination that an individual did not come into contact with an item of evidence.

This report contains the results of the examination of friction ridge prints.

Results of Examinations:

Seven latent fingerprints of value were detected on Q14, Q16.6, and Q19. No latent prints of value were detected on the remaining specimens.

Automated latent fingerprint searches were conducted, but no identification was effected.

Methods:

Items of evidence submitted to the Latent Print Operations Unit for examination may be examined visually, examined with various light sources, and/or processed with chemicals and powders to detect the presence of latent friction ridge prints. The specific sequence of examinations and processes depends upon the nature of the evidence.

Friction ridge print examinations are conducted using the Analysis, Comparison, Evaluation, and Verification methodology (ACE-V), which includes an assessment of the quantity and quality of the information present. The steps of ACE-V are applied to each examination as appropriate.

Analysis is the assessment of a friction ridge print to determine if sufficient reliable details are present to conduct a comparison with another print and to reach an identification conclusion. If these conditions are met, the print is determined to be "of value".

Comparison is the direct side-by-side observation of friction ridge prints of value to determine whether or not the information in two prints is in agreement.

Evaluation is the formulation of a conclusion based on the information gathered during the analysis and comparison of the friction ridge prints.

Conclusions that can be reached are as follows:

- Identification - the determination that there is sufficient quality and quantity of detail in agreement to conclude that two friction ridge prints originated from the same source.
- Exclusion - the determination that there is sufficient quality and quantity of detail in disagreement to conclude that two friction ridge prints did not originate from the same source.
- Inconclusive - the determination that corresponding areas of friction ridge prints are absent and/or unreliable and therefore cannot be identified or excluded.

Verification is the independent application of the analysis, comparison, and evaluation phases of the ACE-V methodology to a friction ridge print by another examiner.

Interpretations:

The presence of a friction ridge print on an item of evidence indicates contact was made between the source and the item of evidence. The presence of a friction ridge print alone does not necessarily indicate the significance of the contact nor the time frame during which the contact occurred.

Due to the many factors involved in the deposition of a friction ridge print, neither the absence of a friction ridge print on evidence nor the exclusion of a friction ridge print with a given source, disassociate that source from having touched the evidence.

Remarks:

Inasmuch as a latent print examination was conducted on Q11, Q11.6, Q12, Q28, Q29, Q29.1, Q30, Q30.5, Q31, Q32, Q33, Q34, Q37, Q37.1, Q37.2, Q37.3, Q37.4, Q37.5, Q37.6; Q38, Q39, Q39.6, and Q40 by an agency other than the FBI, no latent print examinations were conducted on these items.

Synopsis: Closure of captioned matter.

Details: This matter was opened as a result of the receipt of approximately 30 letters containing white powder via U.S. Mail at several Church of Scientology locations throughout Southern California on or about 01/31/2008. Subsequent investigation and forensic examinations of the evidence have failed to reveal sufficient evidence to determine those responsible for this act.

The white powder contained in the envelopes received by the Church of Scientology was determined to be non-toxic by both local LRN laboratory and the FBI laboratory. Several other examinations by the FBI lab were unable to determine sufficient identifying information to point toward one or more individuals who might have handled the evidence. Serial 49 documented the results of the fingerprint analysis of the evidence. From this examination the following statement was submitted..."Seven latent fingerprints of value were detected on Q14, Q16.6, and Q19. No latent prints of value were detected on the remaining specimens. Automated latent fingerprint searches were conducted, but no identification was effected."

All other investigative leads in this matter have been exhausted. Due to the fact that no one person could be identified, through the course of this investigation, as possibly
